#### **Guidelines**

- All participants must register prior to starting the tour and receive a wrist band to be admitted to any of the homes. Adults (+16) only permitted on this tour.
- Tickets / wrist bands can be purchased prior to the event or on the day of the event. Pontoon boat in front of the Diven Cottage / East Shore will be ticket sale location on the day of event.
- Cottage tour is by boat only. Admittance will not be allowed from shore access nor driving your car.
- After receiving your wrist band, your boat may start the tour at any of the tour homes located on the map provided to you. This will decrease any “bottle necks” / slowdowns with many boats trying to start the tour at one cottage location.
- Restrooms / bathrooms will NOT be available at the tour houses. Please don't ask!
- Homeowner may provide an area for visitors to leave their shoes while touring the home (if desired).
- Taking pictures of the interior of the home is NOT permitted.
- Information sheets will be available for each tour home describing the unique features and history of the property. Check at registration for this information sheet.
- Tour volunteers will be available to assist participants disembarking from their boat onto the dock at each tour home. Dock volunteers may suggest that you go to another tour home and return later to that location in order to move participants quickly through the homes.
- Cottage tour may be rescheduled to Sunday 7/14/2013 or another weekend due to weather conditions.
- There will be NO REFUNDS on donations for the Cottage Tour. Please keep your wrist bands as they will be your admission ticket if the tour is rescheduled.
- Have a great time meeting your neighbors. Please thank our cottage owners for opening their homes for your enjoyment.
